

Community Meeting Blue Ridge High School March 25, 2008

About 50 people attended the first *Imagine Greenville County* Community Meeting. The meeting was held in the auditorium of Blue Ridge High School and featured a short presentation on the process of creating a plan and the importance of doing the job the right way. The message was simple: while plans are made by many counties all over the state, not all are made equal. For this plan to work, it begins with the public—and with meetings like these.

Following the presentation, the floor was opened for attendees to discuss their concerns. A list of these concerns is shown below. Once compiled, attendees then prioritized these issues by placing "voting dots" on those matters that were most important to them. These dots were simple round stickers but they had a unique value because each individual had only four such dots at their disposal. Thus, when choosing where to place these dots (and their priorities), participants could only highlight issues at the heart of their concern.

The following comments show the result. The number to the right of each comment represents the number of dots that were given that comment. The higher the number of dots, the greater the priority. Thus, for the Blue Ridge community, the biggest, most crucial concern is the protection of natural resources and water supply.
